What is a DPS

A DPS or Dynamic Purchasing System is an electronic system which contractors can join at any time during the life of the arrangement.

The DPS may be divided into categories of works known as Lots and regions

Contractors are pre-qualified, so can bid for any opportunity they are invited to.

For the MoJ

- Flexible
- Complementary provision of works
- Added resilience to our sourcing landscape
- Increased agility for GFSL

Why Join

Contractor Benefits of DPS

- Easy and proportionate entry requirements- great for SMEs
- The approval process and the award of tenders are fast
- You can join at any time because the DPS will remain open to new suppliers throughout its lifetime
- Contractors can apply for additional lots if need be throughout its life
- Encourages Localism
- Saves time on admin, once set up, you can bid for works you are invited to bid for, you do not need to complete the same form twice
- Value for money
- It is free to join!

What is the MoJ Minor Works DPS

Lot 1 – Building Structure and Groundworks

Building/building fabric; flooring; painting and decorating; road maintenance; roofing; scaffolding, powered access & abseiling, cherry pickers; fire protection / safety remedial work (passive); glazing; landscaping/grounds maintenance; health facility refurbishment; brickwork; plastering; fencing and gates; sustainability – e.g. Insulation.

Lot 2 – Mechanical Engineering incl. HVAC

Boilers, heaters and associated plant; air handling units; filters; ventilation and extraction; water systems – servicing, legionella testing, thermostatic; mechanical catering equipment; catering plant – mechanical; lift maintenance; hydraulic gates; sustainability – e.g. ground source heat pumps.

Lot 3 – Electrical Engineering incl. Security

Electrical installation and maintenance services; emergency lighting and power; security, access control, intruder and CCTV systems; catering plant – electrical; sustainability – e.g. PV cells.

Lot 4 – Demolition Work

All demolition work, including Services (gas/electric/water); asbestos removal, skip hire.

Lot 5 – Multidisciplinary Construction Work

Any combination of work elements.

What is the MoJ Minor Works DPS

The DPS will be used, predominantly in the prison space.

- Project work Majority minor works contracts will be <£500k and will not exceed £1m.
- GFSL Maintenance needs and resultant remedial works.

The DPS platform is being hosted by Constructionline.



4+2+2 years – an anticipated duration of 8 years.



How to take part:



Call Off Competitions under the Minor Works DPS allows contractors to understand the precise requirements of the project in order to submit their proposal and price.

Important points:

- 1. No obligation on suppliers to bid in Call Off Competitions.
- 2. Contractors will <u>only</u> be invited to Call Off Competitions for their selected Categories and within their Notation contract values limit / geographical locations when they have been successful and onboarded onto the DPS arrangement.
- 3. The call off process should take approx. 7 wks. Bid 3 wk. Evaluation should take 1 2 weeks, approval of recommendation to award should take no more than 2 weeks. Notification of outcome.
- 4. A period of time will be allowed for 'new' contractors to obtain security clearance and sign up to the payment system.
- 5. Works supervised by MoJ or GFSL staff members. The FM SP will provide access to site records


